ORDER:

In the reference 1st cited, the Additional Secretary/APTRANSCO has informed that the issue for creation of Supernumerary posts on alternative arrangement to accommodate the dependent of the deceased employees was discussed in CMD's conference held on 25-03-08 and it was decided that for appointment on compassionate grounds, if there is no vacancy in equivalent cadre in any Circle, any redundant vacancy in O&M Cadre may be downgraded and utilized for appointment under the Scheme.

In the reference 2nd cited, the Additional Secretary/APTRANSCO has informed that, on the request of the Employees Unions to implement GO Ms.No.427, dt. 01-07-1991 regarding creation of supernumerary posts to accommodate the dependents of the deceased employees and during the discussions held with them, the management of APTRANSCO has agreed to remove the words "O&M cadre" mentioned in the letter dt. 27-3-08, in case of appointment on compassionate grounds if there is no vacancy in equivalent cadre and requested to take necessary action accordingly.

3) In view of the above instructions, a proposal was placed before Board of Directors for approval for down-gradation of redundant vacancies in O&M Cadre and other than O&M Cadre in APEPDCL mentioned in the Annexure. for utilisation as Watchman, SWG and Office Sub-Ordinates to accommodate the dependents of deceased employees appointed on compassionate grounds, in its 60th Board Meeting held on 24-09-09 at Visakhapatnam.

4) After careful examination of the proposal, the APEPDCL Board has considered the proposal for down-gradation of 18 redundant vacancies existing in O&M Cadre and other than O&M cadre in APEPDCL for utilisation as Watchman, SWG and Office Sub-Ordinates, to accommodate the dependents of deceased employees appointed on compassionate grounds

5) Allocation of above said posts will be issued separately.


