ORDER:

In T.O.O 3rd cited, orders were issued superceding the orders issued in Board's Memo 2nd cited, prescribing ITI qualification as essential prospectively for appointment by transfer of Attenders/Watchmen to the post of Junior Lineman (being a technical post). Accordingly, orders were issued in APEPDCL vide reference 4th cited.

2) In the reference 5th cited, the APTRANSCO has issued orders granting relaxation of qualification of I.T.I. to the post of Junior Lineman under appointment by transfer from the categories of Office Sub-ordinate and Watchman subject to the conditions mentioned therein. Again similar orders were issued by the APEPDCL vide reference 6th cited.

3) In the reference 7th cited, APTRANSCO has issued amendment to T.O.O. (Addl. Secy.-Per) Ms. No. 72, Dt. 20.06.2009 mentioned under reference 5th cited.

4) After careful consideration, Eastern Power Distribution Company of A.P. Limited here by issues the following amendment to E.O.O (HRD) Ms. No. 160, Dt. 16.07.2009 mentioned under reference 6th cited.

AMENDMENT

The paras 5, 6, & 7 of E.O.O (HRD) Ms. No. 160, Dt. 16.07.2009 shall be substituted with the following paras.

Para – 5: The Employees Unions have requested to extend relaxation of qualification of I.T.I. to the post of Junior Lineman under appointment by transfer from the category of Sweeper-cum-Gardner (SWG) in addition to Office Sub-ordinate and Watchman. In CMDs conference held on 15.09.09 the request of the unions was discussed in detail and a consensus decision was taken to relax I.T.I. qualification for appointment by transfer to the post of Junior Lineman from the category of Sweeper-cum-Gardner (SWG) in addition to Office Sub-ordinate and Watchman subject to the conditions mentioned in E.O.O. (HRD) Ms. No. 160, Dt. 16.07.2009.

Para – 6: In supercession of orders issued vide T.O.O. 3rd cited, Transmission Corporation of A.P. Limited granted relaxation of qualification of I.T.I. to the posts of Junior Lineman under appointment by transfer from the categories of Office Sub-ordinate, Watchman & Sweeper-cum-Gardner (SWG); subject to the certain conditions.

Para – 7: After careful consideration and in supercession of orders issued in the reference 4th cited, the APEPDCL hereby grants relaxation of qualification of ITI to the post of Junior Lineman under appointment by transfer from the categories of Office Sub-ordinate, Watchman & Sweeper-cum-Gardner (SWG); subject to the following conditions:

- i) Employee who has possessed SSC qualification shall be considered for appointment to the post of Junior Lineman subject to the condition that the candidate shall acquire I.T.I qualification within four (4) years from the date of appointment by transfer. If the candidate fails to acquire the qualification within the prescribed time limit the commencement of probation shall be postponed till such time the said qualification is acquired.
 - ii) The appointments by transfer to the post of Junior Lineman shall be considered subject to fulfilling all other conditions stipulated from time to time and subject to availability of vacancies.
- 5) The other conditions mentioned/stipulated in E.O.O. 6th cited are unaltered/ unchanged.
