**ORDER:**

In partial modification of the promotion orders issued vide reference 5<sup>th</sup> cited, the following orders were issued in respect of Sri S.Masilamani, Ex ADE/El now DE/PP/Corporate Office/Visakhapatnam:

Sri S.Masilamani, Ex ADE/El now DE/PP/Corporate Office/Visakhapatnam placed below Sri B.V.Ramana, Ex ADE/El now retired and above Sri.Y.Vishru, ADE/El was empanelled in the Main panel prepared for the panel year 2006-07 subject to finalization of the disciplinary cases pending against him. Subsequently, the disciplinary cases against Sri S.Masilamani, Ex ADE/El now DE/El were finalized as "WARNED" and "DROPPED" respectively vide references 1<sup>st</sup> and 2<sup>nd</sup> cited. Hence in terms of Reg. 3 (B) (iii) (a) of APSE Board Service Regulations Part-III and Regulation 8 (2) (f) of Service Regulations part-II of APSEB as adopted by APEPDCL, his case is reviewed and he is eligible for notional promotion as Divisional Engineer/El on par with his immediate junior Sri N.Ramesh, DE/El who has assumed charge on promotion as Divisional Engineer/El on 16.07.2007 AN as per the orders issued vide reference 4<sup>th</sup> cited, and whose case was considered for notional promotion, vide E.O.O. 6<sup>th</sup> cited, on par with his immediate junior Sri M.Venkateswara Rao, DE/El who has assumed charge on promotion as Divisional Engineer/El on 07.05.2007 FN as per the orders issued vide reference 3<sup>rd</sup> cited. However, Sri S.Masilamani, DE/El will be eligible for monetary benefit from the date of actual assumption of charge on promotion as Divisional Engineer/El i.e., w.e.f 23.09.2009 FN only.

2. After careful consideration, the APEPDCL accords approval for the following:
  - i) Sri S.Masilamani, Ex ADE/El now DE/El shall be notionally promoted as Divisional Engineer/El from the date of assumption of charge of his Junior Sri M.Venkateswara Rao, DE/El on promotion as Divisional Engineer/El i.e., w.e.f 07.05.2007 FN.
  - ii) However, he will be eligible for monetary benefit only from the date of actual assumption of charge as Divisional Engineer/El i.e. with effect from 23.09.2009 FN.
  - iii) The other terms and conditions ordered in the E.O.O. 5<sup>th</sup> cited are unaltered.
