ORDER:

The Eastern Power Distribution Company of Andhra Pradesh Limited hereby accords sanction for the rates of Dearness Allowance to all the employees of APEPDCL in the Revised Pay Scales 2010 and Dearness Relief to the Pensioners/Family Pensioners with effect from 01.07.2010 as indicated below:

i) Dearness Allowance to the employees drawing Revised Pay Scales of 2010: -

a) Dearness Allowance rates from 01.07.2010 : 6.888% of pay

ii) Dearness Relief to the Pensioners/Family Pensioners: -

a) Dearness Relief rates from 01.07.2010 : 6.888% of Pension/
Family pension.

2) The arrears of Dearness Allowance as per the increased rates for the month of July '2010 shall be paid in cash along with salary for the month of August' 2010 payable in September' 2010 to all the employees of APEPDCL.

3) The arrears of Dearness Relief to Pensioners/Family Pensioners as per the increased rates for the month of July '2010 shall be paid in cash along with the Pension/Family Pension for the month of August '2010 payable in September' 2010.

4) The Dearness Allowance so calculated be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next higher rupee.
