**ORDER:-**

In E.O.O. (HRD) Ms.No.55, dt. 02-03-09, orders were issued prescribing the eligibility criteria for appointment by transfer to the post of Sub-Engineer as per TOO 1<sup>st</sup> cited and in E.O.O.(HRD) Ms.No.56, dt. 02-03-09 amendments to APSEB Service Regulations Part-III as adopted by APEPDCL were issued for appointment by transfer to the post of Sub-Engineer as per TOO 2<sup>nd</sup> cited.

2) In the EOO (HRD) Ms.No. 106, dt. 29-04-09, amendment orders were issued to E.O.O. (HRD) Ms.No.55, dt. 02-03-09 and E.O.O. (HRD) Ms.No.56, dt. 02-03-09 regarding eligibility criteria for appointment by transfer to the post of Sub-Engineer as per TOO 5<sup>th</sup> cited.

3) In the TOO 7<sup>th</sup> cited, the APTRANSCO has issued amendments to the TOO 1<sup>st</sup> and 5<sup>th</sup> cited.

4) After careful consideration Eastern Power Distribution Company of AP Limited issues the following amendments to the E.O.O.(HRD) Ms.No.55, dt. 02-03-09 read with E.O.O. (HRD) Ms.No.106, dt. 29-4-09.

**Amendment -I**

Clause (a) in para 3 of E.O.O. (HRD) Ms.No.55, dt. 02-03-09 read with E.O.O. (HRD) Ms.No. 106, dt. 29-04-09 may be read as "In service employees working in any service (i.e., Accounts, P&G and O&M) carrying "equal to" or "below" the time scale of pay of Sub-Engineer cadre are eligible for appointment by transfer to the post of Sub-Engineer".

**Amendment-II**

Clause ( c) of para 3 of E.O.O. (HRD)Ms.No.55, dt. 02-03-09, shall be deleted.

Accordingly, the Eastern Power Corporate of AP Limited in exercise of the powers referred to in Regulation 41 of APSEB Service Regulations Part-II as adopted by APEPDCL and Rule 7 of the Andhra Pradesh Electricity Reforms (Transfer Scheme) Rules, 1999, hereby issues the following amendment to APSEB Service Regulations Part-III as adopted by APEPDCL.

**Amendment**

The existing provision in clause (c) under item-ii Column-2 - Sub-Engineer/Electrical/Mechanical/Civil/Telecommunications under sub-heading others - Class-III under main heading Branch VI - Draughtsman in Annexure-1 of APSEB Service Regulations Part-III shall be deleted.
