ORDER:

The scale of pay of Workmen & other than Workmen was revised w.e.f.01.04.2010 in the references 3<sup>rd</sup> cited, duly adopting the APTRANSCO orders vide reference 1<sup>st</sup> & 2<sup>nd</sup> cited. This opportunity shall be given on one time basis subject to condition that the revised option shall be exercised on or before 31.03.2011.
- 4) All other principles/conditions mentioned in T.O.O.s vide reference 1<sup>st</sup> & 2<sup>nd</sup> cited above shall remain unaltered/unchanged.
