**ORDER:-**

In the G.O 1<sup>st</sup> read above Government of Andhra Pradesh have issued orders duly relaxing the Upper Age limit by 2 years for the ensuing recruitments through A.P. Public Service Commission and other Recruiting Agencies.

2) In the reference 2<sup>nd</sup> cited AP Transco has issued orders directing that the maximum age limit prescribed in regulation 16 of APSEB Service Regulations Part-II as adopted by APTRANSCO for appointment by direct recruitment shall be raised by "Two Years" i.e. from 34 to 36 years for the purpose of direct recruitment to the various categories of posts in all services except O&M Service already notified/to be notified between 01.07.2011 to 31.03.2012 by APTRANSCO. The age concession over and above the upper age limit shall also be allowed to the categories as provided under Regulation 16 of APSEB Service Regulations Part-II. Provided that the above age relaxation of two years shall be applicable for the notifications issued after 01.07.2011 for which the last date of submission of application is not yet over.

3) After careful examination, the Eastern Power Distribution Company of Andhra Pradesh Limited hereby adopts the orders issued by AP Transco in the reference 2<sup>nd</sup> cited.
