**ORDER:**

In the references read above, the Unions/Associations have requested the APTRANSCO to deduct one day basic pay from the salaries of their members working in APTRANSCO, APGENCO and DISCOMs and send the proceeds to "Chief Minister's Relief Fund, Government of A.P" towards "Flood victims".

2. After careful consideration, the APTRANSCO directs that all the Pay drawing Officers in APTRANSCO, APGENCO and DISCOMs shall deduct one day basic pay (rounded off to the nearest rupee) from the salary of the Employees of APTRANSCO, APGENCO and DISCOMs for the month of October, 2009, payable in November, 2009 towards contribution to the "Chief Minister's Relief Fund" for Flood victims.

3. The following working instructions are issued:

- a) The deduction towards one day basic pay from salary is applicable to all the employees working in APTRANSCO.
- b) The amount of deduction shall be rounded off to the nearest rupee.
- c) The deduction shall be effected from the pay bill of October, 2009 payable in November, 2009 by preparing necessary schedules for each pay bill.
- d) The total amount thus recovered from each of the employee's pay shall be credited to the Head of Accounts of Chief Minister's Relief Fund for

Flood victims A/c.No.44.425

The amount so credited are to be shown distinctly in the trial balance without clubbing with other remittances. The employee wise details of recovery schedule duly tallying with the amount shown in trial balance is to be furnished along with the Trial Balance.

- f) If any employee's contribution could not be recovered from October 2009 pay bills for reasons such as non-drawal of salary due to proceeding on leave etc., the contribution shall be recovered from the next immediate duty pay bill invariably.
- g) The recovery particulars indicating the name of employee, Designation and amount particulars may be furnished to Pay Officer, O/o FA&CCA(R&A) and to Dy.Chief Controller of Accounts (Accounts) in respect of APTRANSCO units.
4. All the Drawing Officers of APTRANSCO are requested to follow the above working instructions scrupulously.
5. The Managing Director, APGENCO & the Chairman & Managing Directors of DISCOMs are requested to issue necessary instructions to the Drawing and Disbursing Officers concerned for effecting recovery of one day basic pay from the salary of their employees for the month of October, 2009 payable in November, 2009 and the Pay Officer of DISCOMs concerned has to obtain the details as mentioned at para 3 (g) and send a consolidated cheque either directly or through Dy.CCA/APPCC in favour of "Pay Officer", APTRANSCO along with recovery particulars. The Pay Officer/APGENCO has to obtain the details as mentioned at para 3 (g) and send a consolidated cheque in favour of "Chief Minister's Relief Fund" to APTRANSCO along with recovery particulars.
6. The AO(CPR)/APTRANSCO/VS/Hyd is authorised to claim the above amount on behalf of APTRANSCO employees and on behalf of four DISCOMs and remit the same to the Chief Minister's Relief Fund
