Sub: APEPDCL – HRD – Estt/ NT – Minimum service required for promotion to the category of Personnel Officers from the category of Junior Personnel Officers – Relaxation on one time basis — Orders – Issued.

According to Regulation 14 of APSEB Service Regulations Part-III as adopted by APEPDCL read with the provisions contained in Annexure – VI, Junior Personnel Officers are eligible for promotion as Personnel Officers, if they must have had experience of not less than 7 years as Junior Personnel Officers.

2) In view of the Number of vacancies of Personnel Officers existing in APEPDCL and in view of the shortage of candidates who have put in the minimum service of 7 years, it has been decided in the 68th Meeting of Board of Directors held on 22.6.2011 to consider to reduce the minimum service in Junior Personnel Officer cadre from 7 years to 5 years as a special case on one time basis to promote the eligible Junior Personnel Officers who have completed 5 years of service in Junior Personnel Officer cadre to fill up the vacant Personnel Officer posts.

3) After careful consideration, the APEPDCL hereby directs that in relaxation of the relevant provisions in the aforesaid Regulations referred to above, all the eligible Junior Personnel Officers who have completed 5 years of service in the category of Junior Personnel Officers shall be considered for promotion as Personnel Officers **on one time basis** to fill up the vacancies of Personnel Officers existing as on the date of issue of these orders as a special case and this will not be a precedent in future.
