In the reference 2nd cited, orders were issued revising the Conveyance Allowance to Superintending Engineer and Equivalent Cadres who are working in Corporate Office, Visakhapatnam duly adopting the APTRANSCO orders vide reference 1st cited, the details are as follows:

i)	Within a radius of 5 KM	:	Rs.1295/- pm
ii)	Above 5 KM and upto 10 KM	:	Rs.2590/- pm
iii)	Beyond 10 KM	:	Rs.3240/- pm

2) In the reference 3rd cited, APTRANSCO has issued orders that the maximum existing Conveyance Allowance of Rs.3240/- p.m. shall be allowed as Conveyance Allowance to all Superintending Engineer and Equivalent Cadres who are working in Vidyut Soudha uniformly irrespective of the distance i.e. radius.

3) After careful examination of the issue, the APEPDCL hereby orders that Conveyance Allowance shall be allowed to all Superintending Engineer and Equivalent Cadres who are working in Corporate Office, Visakhapatnam as per the rates mentioned at para no. (1) above only i.e., the orders issued in the reference 2nd cited holds good.

4) The Pay Officer/Corporate Office/Visakhapatnam is, therefore, requested to take an undertaking from the Superintending Engineer and Equivalent Cadre Officers for their travel from residence to Corporate Office and to allow the Conveyance Allowance accordingly. The undertakings should contain the "clause of responsibility rests with the officer" as and when change of distance takes place.
