In the reference 4<sup>th</sup> cited, the proposals received with regard to providing of employment to the dependents of CJLMs who died while in service due to departmental accidents occurred prior to 26.11.2008 as well as proposals related to normal death/suicide cases have not been considered and proposals were returned with a request to intimate the same to the applicants.

2) In the reference 7<sup>th</sup> cited, APTRANSCO has communicated to consider the proposals for providing employment to the dependents of CJLM who died due to departmental accidents occurred prior to 26.11.2008 also on case to case basis.

3) After careful examination of the issue, it has been decided that in respect of CJLMs who became permanently disabled or died due to an accident or mishap while discharging his official duties like climbing of poles, working on lines or equipment etc., at site occurred prior to 26.11.2008 are also to be considered for employment on compassionate grounds. Accidents occurred while going to and from office are not eligible under this scheme. These cases will be examined for consideration, if the proposals are received in Corporate Office on or before **31.01.2011**.

4) In view of the above, all the Superintending Engineers/Operation/ APEPDCL are requested to re-submit the proposals with regard to providing of employment to the dependents of CJLMs who died while in service due to departmental accidents occurred prior to 26.11.2008(**excluding the proposals pertain to normal death/suicide cases & excluding the proposals already re-submitted in response to this office instructions vide reference 8<sup>th</sup> cited**), after establishing the eligibility of the applicants, vacancy position along with FIR, Accident Report, Detailed Report, postmortem report etc., for taking further necessary action
